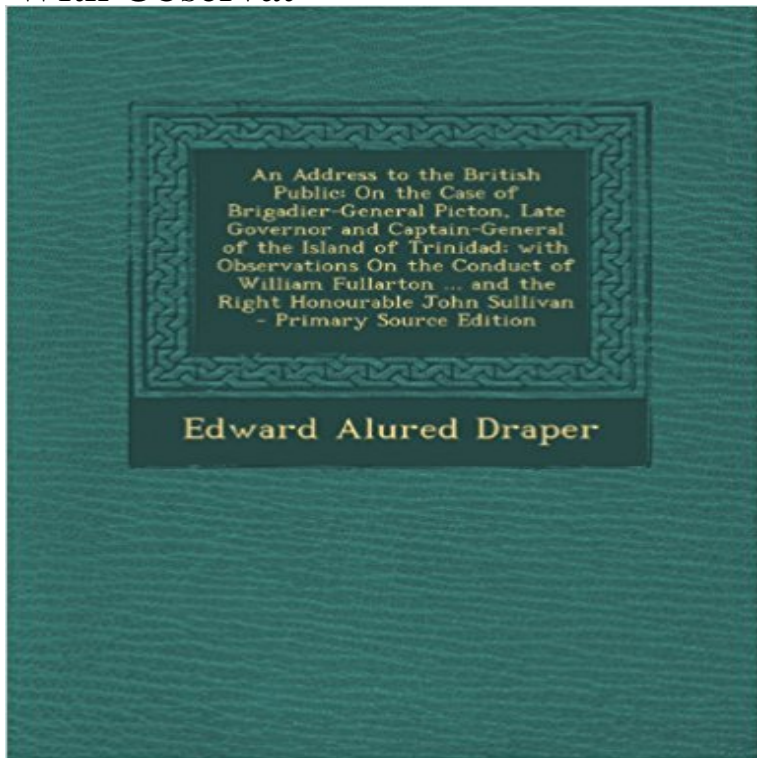


An Address to the British Public: On the Case of Brigadier-General Picton, Late Governor and Captain-General of the Island of Trinidad; With Observat
