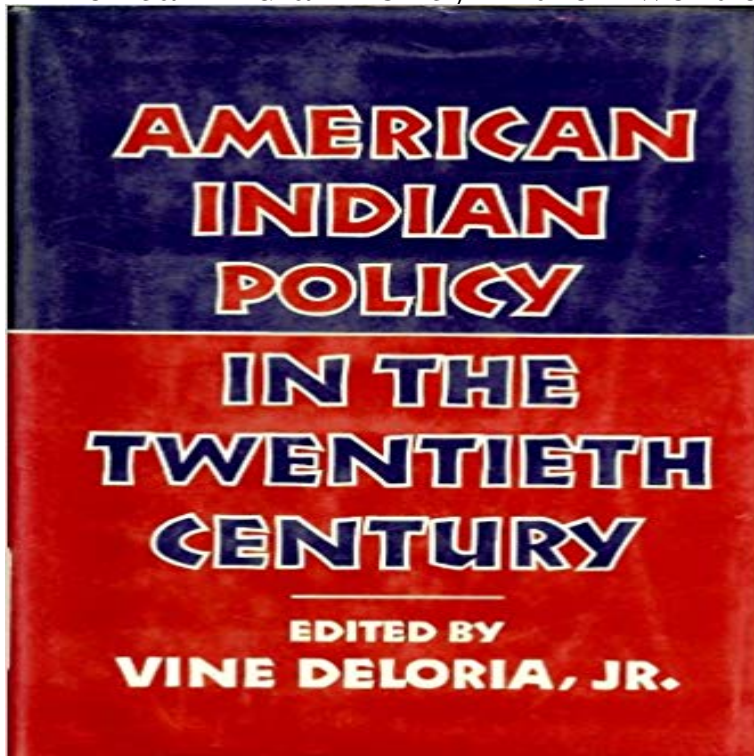


## American Indian Policy in the Twentieth Century
