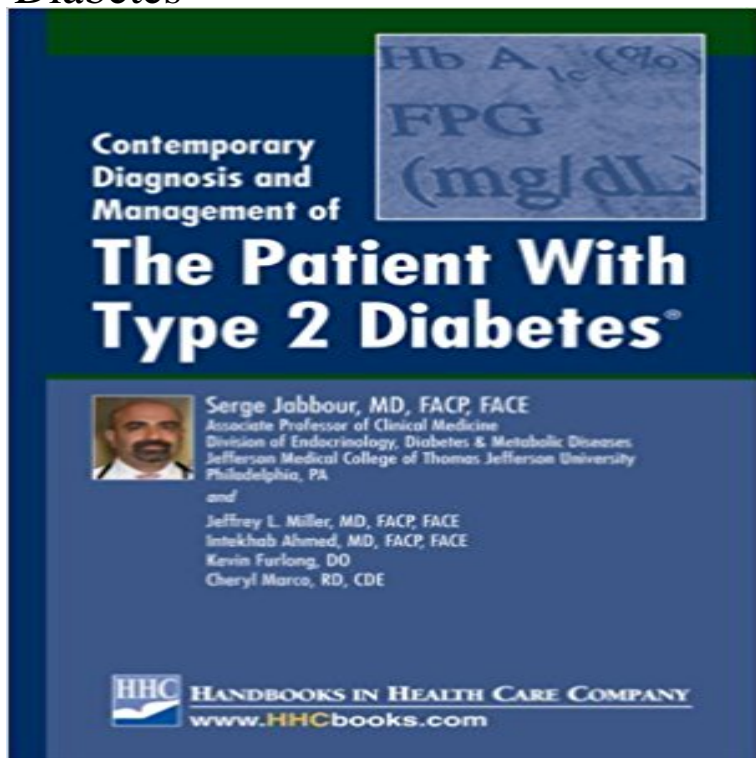


# Contemporary Diagnosis and Management of The Patient With Type 2 Diabetes
