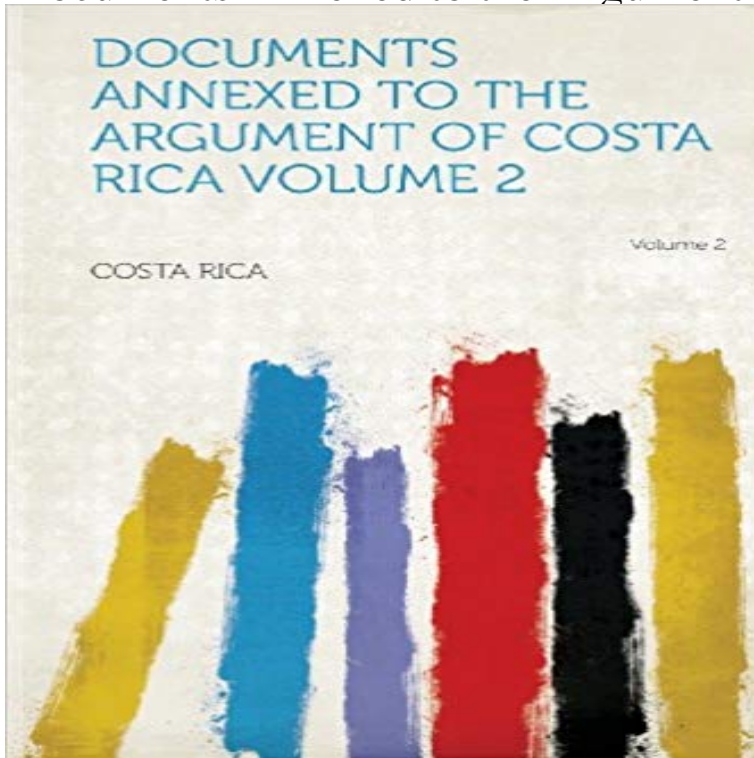


## Documents Annexed to the Argument of Costa Rica Volume 2
