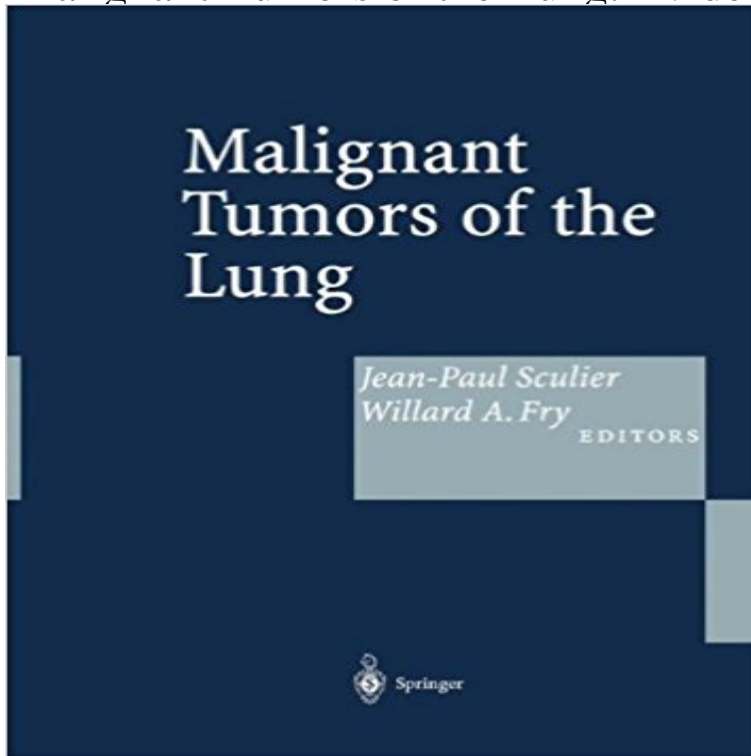


Malignant Tumors of the Lung: Evidence-based Management
