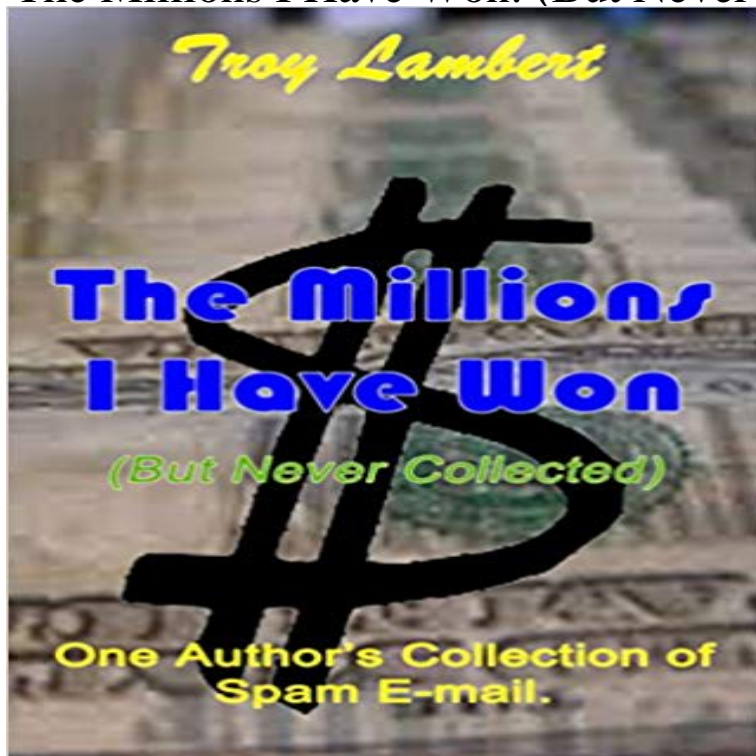


The Millions I Have Won: (But Never Collected)
