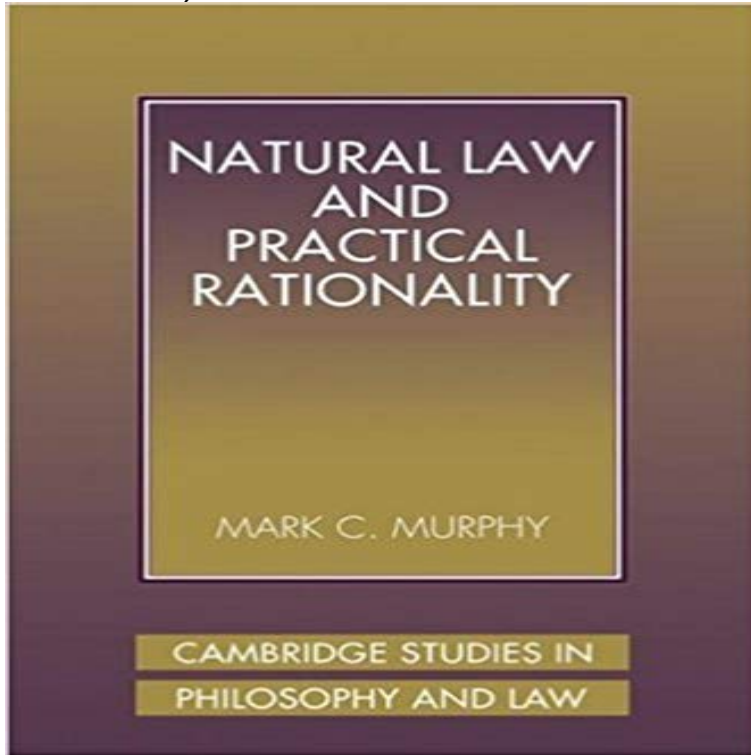


Natural Law and Practical Rationality (Cambridge Studies in Philosophy and Law)
