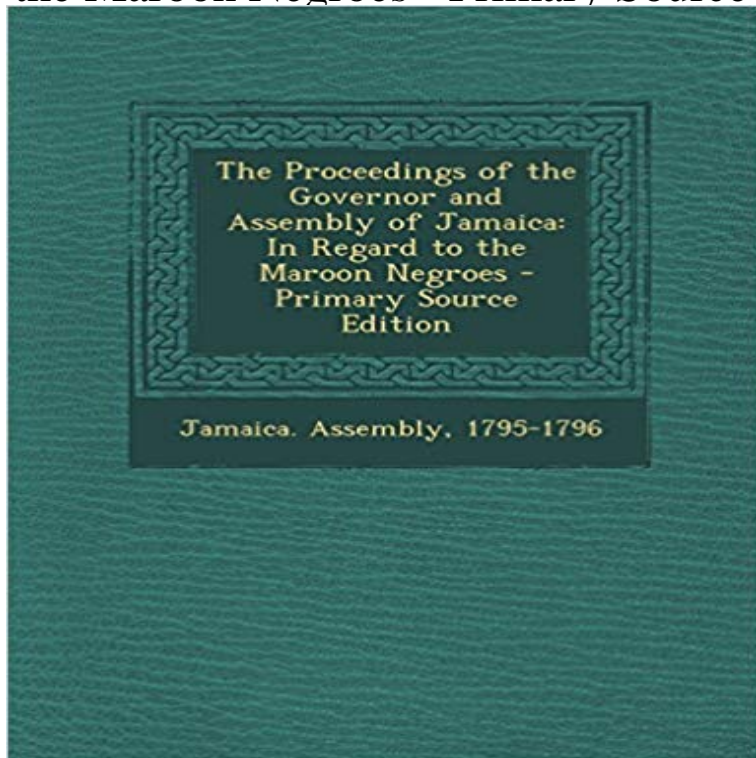


The Proceedings of the Governor and Assembly of Jamaica: In Regard to the Maroon Negroes - Primary Source Edition
