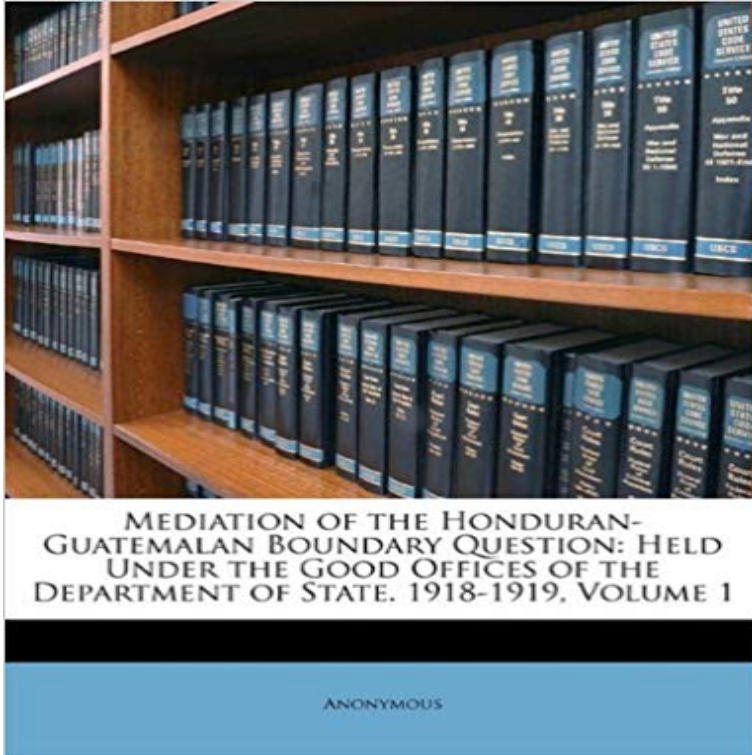


Mediation of the Honduran-Guatemalan Boundary Question: Held Under the Good Offices of the Department of State. 1918-1919, Volume 1
