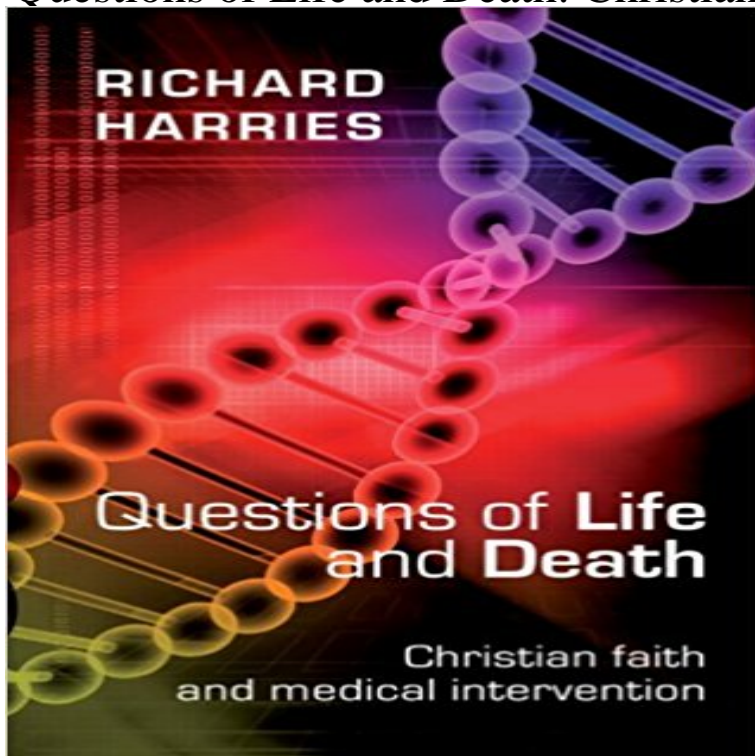


Questions of Life and Death: Christian faith and medical intervention

He shows that the Western Christian tradition is compatible with work in this area. In the House of Lords he was involved in debates on euthanasia, and is critical of much current thinking on the subject.
