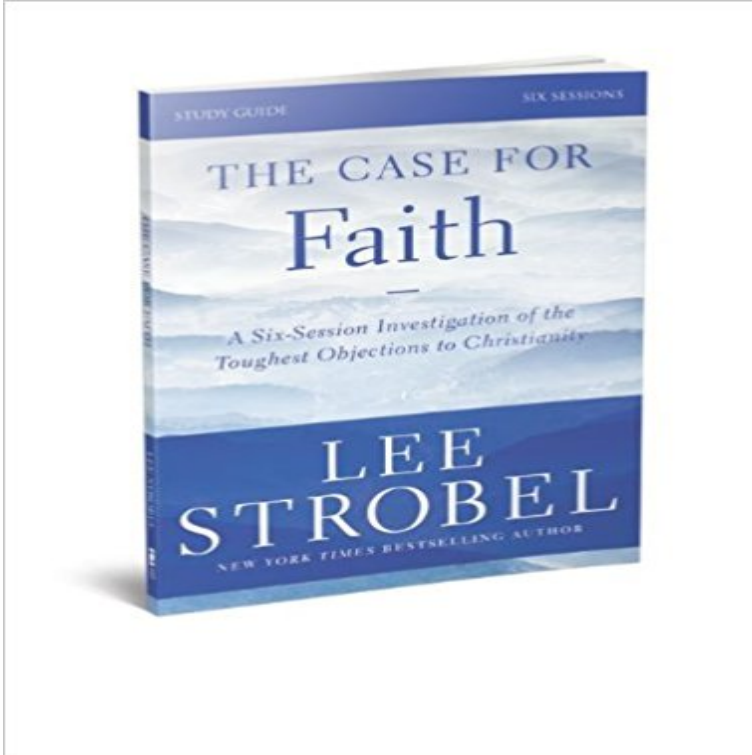


The Case for Faith Study Guide with DVD: A Six-Session Investigation of the Toughest Objections to Christianity
